## **TRAVEL DOCUMENTS:**

A U.S. Passport valid through the date of return is required. Those who are not citizens of the U.S. should contact Gary Markowski for requirements( cubirds@aol.com). Cuban Tourist Cards (visas) are issued at the airport from which you depart directly to Cuba.

## **HEALTH REQUIREMENTS:**

Check with your doctor or the Center for Disease Control in Atlanta. Currently no vaccines are needed for Cuba. In the case of questionable health, the operators reserve the right to require a physician's certification to affirm that you are capable of the activities.

## **RESERVATIONS, APPLICATIONS, DEPOSITS:**

Early reservations are required to insure your place on this trip. All reservations must be accompanied by a completed reservation form and a minimum of **\$ 700.00 deposit**.

## **RATES**

All forms and fares are accurate at the time of publication, March 2018, but are subject to change at any time prior to departure. It is our policy to only pass on the actual amount of any increases in airfares or land costs such as those increases due to the devaluation of the dollar. A price increase may be called for if the group falls below the minimum of 12 participants.

## **CANCELLATIONS AND REFUNDS:**

All cancellations must be done in writing and are effective upon receipt in the Caribbean Conservation Trust office located at 353 West Todd Street, Hamden, CT 06518. Should it become necessary for you to cancel, all payments will be refunded after a deduction of our cancellation fee as outlined in the program description.
